Terms & Conditions:-

That the engagement shall be made purely on academic arrangement basis under SAMAGRA and *General Vacancies* subject to fulfillment of the prescribed criteria requirement basis:-

1. That the candidates must have Masters Degree in the relevant subjects from any recognized University.
2. The eligibility criteria for hiring of the resource persons shall be as per the applicable recruitment rules vide, SRO 481 of 2010, dated- 30.12.2010 of erstwhile J&K government, till the recruitment rules for Lecturer are notified by the Ladakh administration.
3. The candidates should be permanent resident of UT Ladakh as per the provisions of administration of UT Ladakh order No-12-LA (LD) of 2021, dated- 04.09.2021.
4. That the candidates shall have no any claims for regular appointment or confirmation based on the basis of this order on any pretext.
5. That the candidates so engaged shall be treated as terminated soon on joining of permanent Lecturer or commencement of Winter Vacation whichever is earlier.
6. The candidates must be within the prescribed age limit as per norms of the Government.
7. That the candidates shall be engaged in the Institutions on need basis.
8. That the remuneration will be paid in accordance to the norms laid down in the Government Orders/ Instructions issued by the Administration of UT Ladakh vide NO-72-LA (SED) of 2021, dated- 03.12.2021.
9. The number of vacancies may increase or decrease as per the requirement.

- a) 50 points for marks obtained in attaining a Master's Degree in the relevant subjects.
- b) 20 points for written exam. (Off line/On line mode), Ladakh specific general Knowledge (Language, Culture, History).
- c) 20 points for experience of teaching at 10+2 level Schools or colleges affiliated with a recognized board or university at the rate 05 points for each academic session.
- d) 10 points of Higher Qualification, as per the following breakup:-
 - i) 05 points for PhD.
 - ii) 05 points for NET/SET.
